

Membership Dues Schedule

Effective April 1, 2023

REGULAR MEMBERS

- Regular Members must be actively engaged in operating a ski area, or lift-based tourism operation, in Western Canada.

ALPINE & NORDIC SKI AREAS

- Alpine Ski Areas with surface conveyors, aerial lifts and/or gondolas.
- Nordic Ski Areas (including Nordic Clubs).
- Annual dues are based on skier visits (see schedule on next page).

HELICOPTER & CAT SKI OPERATORS

- Helicopter & Cat Ski Operators (without Lift Infrastructure).
- Annual Dues: \$550.00 + GST.

BUSINESSES WITH LIFTS, BUT WITHOUT SKIING

- Tourism businesses that operate lifts, but does not host snow sports.
- Annual Dues: \$415.00 + GST.

ASSOCIATE MEMBERS

Associate Members can fit with the following Associate types:

- CORPORATE - A company or person supplying products and / or services to the ski industry. This membership type also includes regulators and governments.
- OTHER SKI AREAS - Ski areas, or lift-based tourism operations, that are NOT located in Western Canada. This also include ski areas in any location, including Western Canada, that are not actively operating, under construction or in concept.
- NOT-FOR-PROFIT – Associations and other not-for-profit organizations, not including those that meet the definition of a Regular Member (eg non-profit ski areas). These may include, but are not limited to Destination Marketing Organizations, Provincial/National Sports Associations and other industry associations (eg: CSP, CASI, CSIA).

Notes

- CWSAA operations are based on an April 1 – March 31 Fiscal Year. Accordingly, all membership dues are based on this period.
- CWSAA Membership Dues were changed effective April 1, 2023. Prior to this dues schedule, the last change was April 1, 2015.

SCHEDULE 2: Regular Membership Dues

Note: Alpine & Nordic Ski Areas membership dues are based on Annual Skier Visits from two seasons prior, since the most recent season is not completed at the time dues invoices are prepared (eg the 2023/24 dues are based on the 2021/22 dues).

Alpine and Nordic Ski Area members are required to provide their annual skier visits upon completion of each season.
